Dear Special Master Poppiti:

Reference is made to the above referenced legal actions before the United States District Court for the District of Delaware (collectively, the "Lawsuit").

Reference is further made to the following conclusions that appear to have been made in connection with the Lawsuit (or at least C.A. 05-441-JJF):

- NEC COMPUTERS INTERNATIONAL (NEC CI) is in possession of certain documents relevant to the Lawsuit; and
- the corporate successor of NEC COMPUTERS INTERNATIONAL (NEC CI) is the French company NEC COMPUTERS SAS.

Pursuant to the Hague Convention on the taking of evidence in civil or commercial matters, the plaintiffs in C.A. 05-441-JJF requested that NEC COMPUTERS SAS produce certain documents (i.e. those listed on Schedule A to the request for international judicial assistance) (the "Documents"). The *Tribunal de Grande Instance de Nanterre* (the French court), issued an order pursuant to such request on September 3, 2009, directing NEC COMPUTERS SAS to provide you with the Documents.

NEC COMPUTERS SAS is not the successor to NEC COMPUTERS INTERNATIONAL (NEC CI).

TEST TO THE STATE OF THE STATE

Enclosed is the Certificate of Incorporation of PACKARD BELL BV (previously named NEC COMPUTERS INTERNATIONAL (NEC CI)), a private company with limited liability registered and incorporated under the laws of The Netherlands under number 10036009. As indicated on the Certificate of Incorporation, the company currently named PACKARD BELL BV has undergone several name changes and was at one time named NEC COMPUTERS INTERNATIONAL (NEC CI).

Therefore, NEC COMPUTERS SAS is not the successor as the company once named NEC COMPUTERS INTERNATIONAL (NEC CI) remains in existence and operates under the name PACKARD BELL BV.

Notwithstanding the forgoing, NEC COMPUTERS SAS hereby respectfully informs you that PACKARD BELL BV (previously named NEC COMPUTERS INTERNATIONAL (NEC CI)) has provided the Documents to the European Commission.
