SECOND UNOPPOSED MOTION FOR EXTENSION OF TIME FOR LENOVO GROUP LIMITED TO FILE MOTION TO QUASH OR TO LIMIT INTEL CORPORATION'S SUBPOENA DUCES TECUM

COMES NOW LENOVO GROUP LIMITED, BY AND THROUGH ITS COUNSEL AND MOVES AS FOLLOWS:

- 1. On or about April 20, 2010, Lenovo Group Limited ("Lenovo") received service of a Subpoena *Duces Tecum* (the "Subpoena") on behalf of Intel Corporation ("Intel") in the above-captioned matter. The Subpoena includes thirty (30) specifications.
- 2. On April 27, Lenovo filed an unopposed motion for extension of time until May 10 to respond to the subpoena.
- 3. Lenovo and counsel for Intel are in continuing discussions regarding the scope of Intel's specifications, any objections by Lenovo thereto, and the time required for Lenovo to search for, process and produce responsive documents. To facilitate those discussions, Lenovo has requested that Intel agree that Lenovo shall have an additional twenty-one (21) days in which to file a motion to quash or a motion to limit should the parties be unable to resolve all issues regarding the scope of the subpoena and the time required for Lenovo to produce responsive documents.
- 4. Therefore, Lenovo requests that this Court grant it until May 31, 2010 to file a motion to quash or motion to limit, and that Lenovo's obligation to otherwise respond to the

Subpoena shall be tolled during that period. This extension has been agreed upon in order to afford Lenovo and Intel additional time to limit the scope in order to avoid the necessity of filing a motion to quash or a motion to limit.

5. Undersigned counsel represents that he has conferred with counsel for Intel and that Intel does not object to the proposed extension.
