Description of Change to the Customer:

The Intel PRO/100 M Desktop Adapters, PILA8460M MM#854613, PILA8460MBLK20 MM#847578 (Dayville Retail) will End of Life.

The Intel silicon controllers used on these Networking Adapters have announced End of Life on PCN#109390-00, dated July 24th, 2009, as follows; "Intel will be discontinuing the production of its legacy Fast Ethernet 10/100 PCI host-interface Silicon Components. This End of Life (EOL) plan is a LAN Access Division (LAD) business decision influenced by declining demand for all parts manufactured on an old process technology (P854) and the potential of increasing costs."

Customer Impact of Change and Recommended Action:

Customers should place their last time orders by July 30th, 2012, and delivery of all orders must be taken no later than December 31st, 2012. Orders are Non-Cancelable and Non-Returnable after October 30th, 2012, with Technical Support Service ending December 31, 2013.

Note on Discontinued Product Returns:

Approval from Intel, documented by an RMA# reference, must be obtained prior to the return of any product. No credit will be given for products returned by a distributor without prior authorization from Intel and unauthorized returns will be returned to the distributor, freight collect. Intel reserves the right to refuse credit if upon receipt of product it establishes that the terms of return, as defined in this policy, have not been met by distributor or if the product returned does not match the product described on the authorized RMA. Credit for returned products will be calculated based on the cost specified in the current Distributor Cost List in effect on the day that the return is authorized by Intel. Products included in the Discontinued Product Return Notification, as described in Product Discontinuance policy #188000, are not eligible for return under any other Intel® RMA program. No returns of any kind will be accepted for shrink-wrap software products if the shrink-wrap is broken. As indicated below, certain types of RMA product must be returned in the original unopened, undamaged, and unadjusted packaging. Where this requirement is not met, Intel reserves the right to return the product to distributor, freight collect, or to charge distributor a 20% administration fee when calculating credit for return. It is the responsibility of the distributor to ensure that RMA product is adequately protected to reasonably ensure that damage in-transit to Intel does not occur.

Intel encourages all customers to upgrade to 10/100/1000 Mbps adapters. Recommended transition products are noted within the affected products table within this PCN notice.
